





Have your party at Stocksbridge Community Leisure Centre TERMS AND CONDITIONS

Booking

- All parties must be pre-booked, we do not accept any party bookings less than 2 weeks prior to the proposed party date.
- A 25% deposit must be paid within 7 days of receiving your booking confirmation or the booking will be cancelled
- Final balance is due 2 weeks prior, along with the signed declaration form, list of attendees & food order (if applicable) this date will be confirmed on your confirmation letter
- After the final balance has been paid, refunds will not be given for non-attendees

Parties

- All parties are 1 hour long (excluding additional catered food)
- Please make sure you arrive at least 15 minutes before the start of the scheduled party time
- Everyone to meet in reception where you will be greeted by your party host who will then show you where you need to go
- Children are not to be left unsupervised in the building during a party, SCLC is not responsible for children attending parties, this responsibility lies with the party child's parent/guardian for all attendees
- Food is not allowed to be brought into the centre apart from those that have booked the party room afterwards and are able to bring in a birthday cake
- Please do not leave your belongings in the changing rooms, or in lockers which are not locked. SCLC are not responsible for any loss of property.
- The lockers operate by inserting a 50p piece in to the locker which can then be locked
- If your party is in the bowls hall or on the bouncy castle, everyone is to remove outdoor shoes to protect the carpet







Party Room

- The room can only be hired when ordering food from Oxley's, we do not offer room hire for own food to be brought in
- There is a limit of 20 children in the party room
- We do not allow own food to be brought into the Leisure Centre apart from a Birthday cake, this is only available to guests who have the party room booked
- It is your responsibility to ensure you have made your guests aware of the
 ingredients/allergen information for the birthday cake and by signing the declaration
 document you indemnify Stocksbridge Community Leisure Centre against all liability and
 claims arising from the consumption of the cake
- Children must stay in the party room at all times
- We do not allow children to play or run in the vending area
- The nearest toilets are the pool side changing rooms & young children must be supervised by an adult when using the toilet facilities
- Sunday Parties- The centre closes at 1pm on Sunday's, therefore the doors on our reception
 will be closed and for exit only. Customers attending the party room until 2pm will not be
 able to gain access back inside as our reception will not be staffed at this time. If you need to
 pop out for any reason, please ask for the duty manager on shift.







Pool Side Rules

- Everyone to remove outdoor shoes or put blue overshoes on prior to entering the changing rooms
- Should any parents not wish to enter the pool, these parents must use the seating area on the balcony, sitting around the pool area is not permitted at any time
- If a child cannot swim unaided, they <u>must not</u> go past the non-swimmers point (sign located before the middle steps in the main pool)
- The parents/guardians of non-swimmers must bring their own buoyance aids, SCLC cannot provide these
- ALL non-swimmers must wear arm bands, refusal to wear swimming aids will result in the child not being permitted to enter the pool
- The accompanying adult should maintain a constant watch over any children in their care in both the pool and changing areas, and should remain in close contact with weak or nonswimmers.

<u>Please note, there is a 30-person limit in each pool MAXIMUM, if your party is over this limit, our lifeguards have the right to deny access.</u>



- b) One child between the age of four years and seven years

Two adults may supervise a maximum of the following:

- Up to four children under the age of four years providing they are wearing swimming aids (armbands and or other swimming aid)
- b) Two children between the age of four years and seven years





One adult may supervise a maximum of the following:

- a) One children under the age of four years providing they are wearing swimming aids (armbands and or other swimming aid)
- b) One child between the age of four years and seven years

Two adults may supervise a maximum of the following:

- a) Up to *two* children under the age of four years providing they are wearing swimming aids (armbands and or other swimming aid)
- b) Two children between the age of four years and seven years









Children aged 8 and over

Children aged 8 and over may swim unaccompanied, however parents should only permit this if they are satisfied that their child is physically able to manage this. Parents should take into account their child's swimming ability, maturity, confidence and general common sense before allowing their child to swim unaccompanied. Our lifeguards on duty will advise any weak/non-swimmers on which parts of the pool they may use

Double Trouble Inflatable Rules

- a) All users under the age of eight years old must be accompanied by an adult.
- b) Accompanying adults are to swim alongside while child is on inflatable.
- c) Weak or non-swimmers must dismount at the sign labelled 'non swimmer'
- d) **Everyone** will be swim tested prior to session starting.
- e) Parents and toddlers to remain in shallow water.
- f) One or two users will be allowed to enter the inflatable at a time
- g) Inflatable users must keep a safe distance from others to avoid collisions or accidents.
- h) Users **must not** swim underneath the inflatable
- i) Users **must not** dive from the sides of the pool during the session
- j) Users must not climb back on the inflatable at the same point, if they have fallen off
- k) No pushing other users whilst on the inflatable
- I) No hanging on the inflatable
- m) Users must exit feet first from the inflatable

Inflatable weight restrictions

The maximum weight of a user on the inflatable is 70KG or 11 stone.
